THE BIOMIMICRY YOUTH DESIGN CHALLENGE (YDC) PROVIDES A FRAMEWORK FOR MIDDLE AND HIGH SCHOOL STUDENTS TO LEARN STEM AND ENVIRONMENTAL SCIENCE USING BIOMIMICRY AND A PROJECT-BASED EXPERIENCE. THROUGH A 22 LESSON CURRICULUM AND DESIGN CHALLENGE, STUDENTS CONNECT WHAT THEY LEARN ABOUT BIOLOGY, ENGINEERING, AND CLIMATE CHANGE, AND CONNECT THAT KNOWLEDGE TO THE REAL WORLD BY DESIGNING A NATURE-INSPIRED SOLUTION TO A LOCAL CLIMATE CHANGE PROBLEM. IN 2019, 193 TEACHERS FROM 37 STATES REGISTERED; 4,200 STUDENTS WERE IMPACTED, AND TEACHERS FROM 24 COUNTRIES USED OUR CURRICULUM. OUR PROGRAM EVALUATION FOUND THAT 90% OR

BIOMIMICRY GLOBAL DESIGN CHALLENGE FINALISTS ARE INVITED TO JOIN THE BIOMIMICRY LAUNCHPAD, WHERE THEY CONTINUE TO DEVELOP THEIR DESIGNS AND BUSINESS MODELS. THE PROGRAM ACCELERATES THE DEVELOPMENT AND COMMERCIALIZATION OF BIOMIMICRY STARTUP INNOVATIONS AND HELPS SUPPORT THE NEXT GENERATION OF SUSTAINABILITY ENTREPRENEURS.
